To be counted you must turn in your card at the end of the summer. Your best score for each hole is used to determine your "Ringer Score". That score is totaled and your handicap from the first week of June is used to determine your Net score.

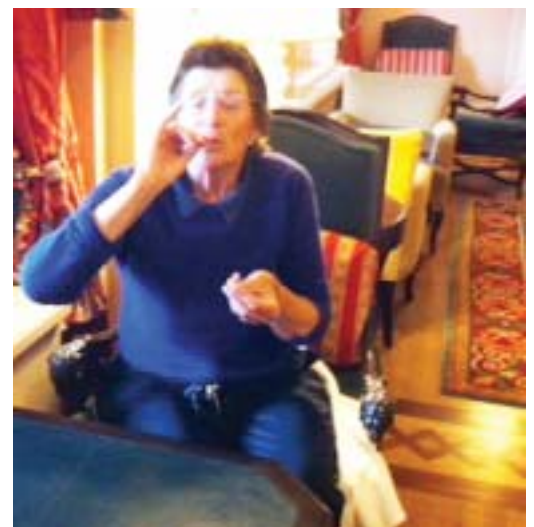

- Team entry fee of \$250.00 includes 9 holes of golf, range balls, and dinner after the round at Mick Kelly's Irish Pub.
- Competition consists of 9 holes of scramble play.
- Teams may consist of one professional only.
- Team handicap will be determined by calculating 20 percent of your team's overall handicap.
- Prizes will be awarded for both gross and net scores, to a minimum of the top 3 teams, based on a full field of 16 teams.
- Hole assignments will be available on riverbendgolfcomplex.com by Thursday, October 27th 6pm.
- Players may sign up as a single player. The tournament committee will assign you a team.
- Any player that does not have USGA ghin handicap will be assigned a 0 handicap.
- **Caution:** Glow balls are much harder than regular golf balls. It is advised to avoid using a driver.

Tournament Refund Policy:

1. If the tournament is postponed, rescheduled, or cancelled by Riverbend Staff, participants will receive a full refund.
2. In the event the play is suspended during the tournament due to unplayable conditions such as weather, and we are unable to resume, participants will receive a full refund.
3. All participants refunds will be issued by the City of Kent, in the form of a check, or applicable credit/debit cards, no cash refunds will be made.
4. The City of Kent will issue participants refund checks within 7 days from the date of the postponement, rescheduling or cancellation.
