2012 PGA/USGA Rules of Golf Workshop Schedule REGISTRATION

Registration for workshops is on a first-come, first-serve basis. Once a workshop site is fully enrolled it will close and no further enrollments for that site will be taken. There are no waiting lists for closed sites. If the site you want to attend is closed, in order to attend a workshop, you will have to register for a workshop at another site.

All workshop communications will be by e-mail, which is why everyone is required to provide an e-mail address at the time of registration. Registration fees for workshops are:

- \$300 for 3 ½-Day Rules Workshops
- \$150 for 2-Day Rules Workshops
- \$100 for exam only registration (10 exam-only seats are available at each 3 ½-day workshop on a 1st-come, 1st-serve basis).

The workshop registration fee must be paid at the time of registration with a credit card (Master Card, Visa, AmEx or Discover). After you have registered, the USGA will e-mail you: •a confirmation receipt and a fact sheet with information detailing the location of the workshop site, local transportation options, hotel(s) where rooms have been locked, information on room pricing and how to make a reservation, if desired. 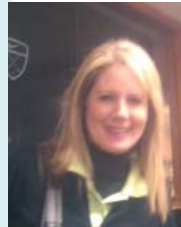

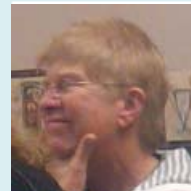

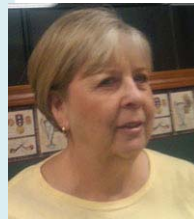
